# Trump campaign funnels millions to 'mysterious' Delaware LLC: Report

Whatever the news surrounding Elon Musk, at least one organization still seems to favor companies formed in Delaware: the presidential campaign of Donald J. Trump.

Committees associated with Donald Trump's reelection campaign have apparently funneled millions of dollars to a mysterious months-old company called Launchpad Strategies LLC whose owners and activities remain somewhat opaque, as first reported Monday by NBC News.

The company was formed late last year in Delaware, according to state business entity filings. Since then, FEC records show that two committees associated with former president Trump's campaign have pushed more than \$3 million in campaign money to that company, for activities ranging from "digital marketing" to "online advertising."

Launchpad Strategies does not seem to have done work for any campaign other than Trump's campaign, according to NBC News.

So what's Launchpad Strategies? And what's former President Trump's history with Delaware LLCs? Here's what we know.

## **Launchpad Strategies LLC is registered at a condo in Dover, Delaware**

Launchpad Strategies' ownership remains opaque, and so does its business. The company was formed as a Delaware LLC in November 2023 through a company called Registered Agent Solutions whose address is a beige office condo in Dover, according to Delaware state records. The condo's owners are a family trust in Phoenix, Arizona with a mailing address in the Florida panhandle.

Calls to the condo's owners were not immediately returned.

On Trump campaign filings, Launchpad's mailing address is listed at a P.O. box in Raleigh, North Carolina, where officials reported that no company by that name exists in that state.



The company's apparent website, launchpad-strategies.com, is a black screen on which the company's logo emerges from a carpet of animated clouds. The website's only feature, aside from that pixelated fog, is a malfunctioning contact form.

## **Launchpad's activities are 'online,' and unclear**

Trump Save America Joint Fundraising Committee is the Trump campaign's main fundraising vehicle. And at \$2.8 million, Launchpad Strategies appeared to receive more money than any entity other than the Trump campaign itself.

Aside from money delivered to the campaign, more than 10% of the Fundraising Committee's payouts to vendors went to Launchpad for services, which were listed as online advertising, digital consulting, and fundraising fees. Trump's campaign also directly paid Launchpad for digital consulting.

Trump's campaign called Launchpad “a digital advertising company that is primarily focused on our fundraising,” in statements to NBC News.

## **Why should anyone care about the opaque ownership of an obscure company few have heard of?**

Election observers Campaign Legal Center, who issued an unsuccessful complaint against the 2020 Trump campaign over a lack of transparency on \$500 million in funds, have called potential shell companies like Launchpad a red flag in an election process where money should be transparent.

“It’s concerning to see a company formed just six months ago suddenly receive over \$3.1 million from Donald Trump’s network of political committees, particularly since there is virtually no public information about this company,” CLC legal director Saurav Ghosh told NBC News on Monday.

## **Trump has a long history of anonymous corporations and dealings in Delaware**

The former president is, of course, no stranger to Delaware LLCs, nor Delaware courts.

In a manner of speaking, it was a Delaware transaction that helped lead to Trump's May fraud trial that ended with felony convictions surrounding purported "hush money"

payments over relationships with porn star Stormy Daniels and Playboy model Karen McDougal.

Trump associate Michael Cohen created two Delaware LLCs, Essential Consultants LLC and Resolution Consultants LLC, reportedly with the intention of orchestrating hundreds of thousands in payments to Daniels and to the National Enquirer's parent company, in order to help keep those affairs quiet before the election.

In 2020, a state judge ordered the dissolution of the two companies created by Michael Cohen.

Federal grand jury indictments in 2016 stated that former Trump campaign chairman Paul Manafort and former Trump campaign official Rick Gates shielded from U.S. authorities millions of dollars in payments from the Ukraine, using nine Delaware LLCs.


Trump Media, whose wildly volatile stock prices have the market's equivalent of tabloid fodder after the company's successful May IPO, was also formed as a Delaware corporation. A battle over the value of shares in that company played out in Delaware courts in March 2024, after a merger with a shell company.

Delaware, has, of course, also been a home for Trump's more intellectual assets. In 2016, Trump moved many of his best-known trademarks, including Trump Tower, the Trumptini and Mar-a-Lago, to a holding company in Delaware.

And, of course, Trump once sponsored a bike race called the Tour de Trump, in Delaware.

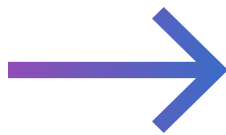

# Why NFX Invested in Moov: The Platform for Buying and Selling Used Manufacturing Equipment

Today Moov announced their \$40M Series A led by Tiger Global, coming 18 months after NFX led their \$4.4M seed round.

Moov Technologies is the #1 B2B platform for buying and selling used manufacturing equipment focused on the integrated circuit manufacturing industry. It integrates payments, logistics, and financial services. The IC industry is going through remarkable evolution and expansion in the US, particularly in the Phoenix area. It's also experiencing significant shortages of equipment. Manufacturers in the IC industry have traditionally looked to phone calling brokers, now they can turn to Moov's 10X digital experience.

Founded by second-time founders Steven Zhou and Maxam Yeung, Moov started in 2018 in San Francisco. They have significant operations in the Phoenix area, but have been named one of the 101 Top San Francisco B2B Companies and Startups of 2021.

Here are 3 reasons why NFX invested in Moov.

## 1. We Believe in B2B Marketplaces

As we detailed in several essays like 24 Ways B2B Marketplaces Win, Fintech Enabled Marketplaces and in The Marketplace Scorecard, we're believers that the 20 year wait for B2B marketplaces ended 3-4 years ago. We've been investing in them since then, and Moov seemed like an obvious fit to that thesis. There are 100's of vertical B2B markets which will digitize in the next 15 years into marketplaces, and integrated circuit manufacturing equipment is a fantastic leading vertical in this broader move.

## 2. Moov's Software Changes The Numbers For Their Industry

One big question with all B2B marketplaces is "How much software can you really apply to the business? In other words, how much human friction can really be replaced with software?" Everyone in the B2B transaction

is gunning for the same thing: margin. So every node in a B2B marketplace is trying to preserve some information advantage over the other nodes and thus they don't want information to be fully transparent as you get in an eBay. Transparency leads to more efficient pricing which can lead to lower margins. It doesn't have to, but this is what the businesses fear. This fear is one of the reasons B2B marketplaces have been so resistant to software for the last 20 years and why still today most existing markets are done purposely with so much friction by personal relationships, phone, email, fax, bank transfers as they have been done since the 1950's.

Turns out Moov, compared to other verticals we've seen, can replace a lot of the transaction process with software. That means transactions can take days not weeks or months, and the equipment can be delivered in weeks rather than 6-8 months. There is higher accuracy and fewer mistakes which means more transactions can happen faster. It also means compliance increases for both sides. Financing is readily available with a click of a button because Moov, with all the data, can immediately underwrite supplier or buyer financing or insurance. This again, increases the number of potential transactions for the entire sector. All this earns Moov a 94% customer approval rating. Moov software allows them to increase sales every quarter without hiring more people. There is a cumulative virtuous cycle around the software that improves all the metrics in the industry.

### 3. Founders

The founding team had spent 10 years in this very market managing transactions by hand the old-fashioned way. They knew the buyers and sellers personally. They knew the brands of equipment, the models of equipment and the equipment specs in their heads. They have the trust of the industry. They are committed to speed and to bringing software to this sector. They have a Silicon Valley mindset, which I would characterize as both comfortable with experimentation and having a long-term outlook with a firm commitment to doing something huge, not something small.

Investors joining the round include public semiconductor investor Gavin Baker of Atrides Management, Valor Equity Partners, Avenir Growth Fund and existing investors.

“We identified an opportunity that existed based on how long the equipment is being used versus how long it’s usable for,” Moov CEO Steven Zhou told TechCrunch in an interview. “There was a billion-dollar opportunity to repurpose this equipment. That’s where the idea of Moov came about. It’s essentially leveraging data and technology automation algorithms to more effectively match unused equipment and find new homes for it all over the world.”

One of Moov’s use cases is to help manufacturing companies recoup capital that would have otherwise been lost. On the buyer side, Moov aims to help small businesses and universities around the world that don’t have the budget or network to acquire equipment to further their innovation.

The platform’s software matches equipment listed by sellers to companies that can use it by automatically serving them those listings. Buyers can also manually search through a mass list of equipment. Along with a real-time marketplace, Moov also features additional services such as logistics, refurbishment, insurance and asset management software.

As for the new funding, Moov plans to use it to expand its domestic presence into other semiconductor hubs such as Austin and New York. It also plans to expand its global presence in China, Taiwan, South Korea, Japan and Europe. The company will also hire executives, invest in research and development and continue to strategically purchase more inventory. Moov also plans to examine acquisition strategies with other industry players that could be plugged into its ecosystem.

Moov’s Series A funding round comes in the midst of the ongoing global chip shortage, as many industries have slowed production because manufacturers are unable to obtain the required equipment. Zhou says that Moov is working to help alleviate local shortages and that the company is able to reduce from months, down to days or hours the lead time for companies to purchase equipment.

The company’s data suggests that the value of used equipment has more than doubled over the past year, and these numbers are expected to continue to grow, doubling to around \$200 billion per year within the next six to eight years. With close to \$1.5 billion in active and available listings on its platform, Moov plans to play a role in shifting the global equipment purchasing mindset.

Zhou says the company is also proud to have built a marketplace that helps to reduce electronic waste globally. “As we grow, we’re really excited to play an increasing role in helping the reduction of the carbon footprint of global manufacturing and also to help alleviate the global chip shortage,” he said.

Executive's decision to step back 'based largely on geography' after move to Florida during pandemic

Scott Shleifer, the head of Tiger Global's \$30bn-plus private equity business, will step down from his role at the hedge fund at the end of the year.

The move will be a significant change for [Tiger](#), a \$58bn-in-assets hedge fund founded by Chase Coleman, a protégé of Julian Robertson, in 2001. Shleifer was one of Tiger's first hires and spotted enormous opportunities from ascendant technology companies, particularly in China, where he was an early backer of ecommerce groups such as JD.com and Ctrip.com.

coronavirus pandemic and has since worked mostly from his home or on the road visiting clients and potential investments.

Tiger has decided that having all of its investment team working from its New York headquarters was a “better operating model for our firm”, it said in a letter to investors announcing the move. Shleifer decided to step back from running the [private equity](#) unit when faced with the decision to move back to New York or stay in Florida, it said.

“Scott’s decision to make this move after two decades of successful partnership is based largely on geography,” the letter said. “Tiger Global is operating in-person out of our New York offices, whereas Scott and his family have made their home in Florida and want to stay there.”

Shleifer will remain as a senior adviser to Tiger, while his private equity role will be replaced with an investment committee chaired by Coleman and consisting of Shleifer and partners Evan Feinberg, Eric Lane and Griffin Schroeder.

The change of guard in Tiger’s private equity business comes at a fraught time for the hedge fund, which saw its assets under management soar to about \$90bn as public and private technology valuations surged during the pandemic.

On Shleifer’s watch, the private equity unit earned large windfalls from early bets on Chinese ecommerce groups JD.com and Meituan, and ride- hailing app Didi Chuxing.

In more recent years he took Silicon Valley by storm by overseeing Tiger’s investments in more than 100 private technology start-ups, including FTX and OpenAI, as it earned a reputation for quickly making large investments and not seeking board representation.

But a sudden rise in interest rates beginning in 2022 left Tiger badly exposed to plunging valuations and holding a bloated portfolio of private investments with limited paths to exit. Its main fund lost half its value in 2022, before recovering strongly along with this year’s rally in tech valuations.

“[Scott] is one of the true pioneers of the crossover investing model [which mixes public and private stakes] and his passion, drive, and commitment have led to many highly profitable investments for the firm including JD.com, Ctrip.com, ByteDance, Booking.com, Apollo, and Google,” Coleman said in the letter.





## Once Part of Trump's Portfolio, Palm Beach Property Sells to Financier Scott Shleifer for \$122.7M

A new build in Palm Beach hit the market last month for \$140 million and was purchased in short order by private equity wiz Scott Shleifer for \$122.7 million. The property, which is one of the most expensive home ever sold in the U.S., was built on a piece of land that had once been owned by President Donald Trump.

According to Bloomberg (<https://www.bloomberg.com/news/articles/2021-01-11/former-trump-property-aims-to-be-palm-beach-s-most-expensive-ever>), Trump picked up the six-acre parcel at a 2004 bankruptcy auction for about \$41 million, ultimately selling it about four years later to billionaire Dmitry Rybolovlev for \$95 million. Rybolovlev subsequently subdivided the property into three lots; they fetched a total of \$108 million.

The house thus stands on two acres of the original lot, and was built on spec by a developer. It is designed in the modern style, and features 21,000 sq. ft. of interior living space. It contains nine bedrooms.

The home was offered as a turnkey lifestyle opportunity, for which there is a considerable market. Part and parcel of the sale were artworks, furniture, and decorative bric-a-brac. Extraordinary amenities include a beauty salon.

The home's rectangular lot includes 140 feet of beachfront.

Shleifer is a partner at Tiger Global Management, where he manages private equity investing, a practice he cofounded at the firm. He made the top 50 of Forbes' Midas List in 2020.

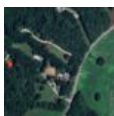

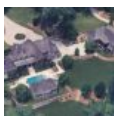

# Inside the \$132 Million Home That Set a Palm Beach Record

Wall Street's bonus season sends prices into the stratosphere

It's Christmas in February for Palm Beach real estate brokers enjoying the fruits of another record bonus season on Wall Street. Markets have stayed buoyant even as other sectors of the economy

Scott Shleifer, co-founder of Tiger Global Management's private-equity unit, set a Palm Beach record yesterday with his purchase of a nine-bedroom, 21,000-square-foot manse for \$132 million. The oceanfront home sits on property formerly owned by Donald Trump, was sold fully-furnished, and features an outdoor movie theater.

And Shleifer, who appears to have gotten a deal on the \$140 million listing price, is not the only deep-pocketed buyer shopping for real estate in paradise.

Hedge funder David Tepper is also in contract on a \$73 million Palm Beach home, according to the *Wall Street Journal*. But the island's biggest shopper is billionaire Ken Griffin, whose portfolio of Palm Beach properties is valued at over \$350 million, including a \$99 million estate purchased just over a year ago.

"Shleifer's partner, Chase Coleman III, made \$3 billion in 2020 making him the world's top hedge fund manager," an insider tells *Avenue*. Coleman's shrewd bets include positions in Peloton and Zoom, which have exploded in value during the pandemic.

His wife is Stephanie Ercklentz who, as the always tactful *Daily Mail* reminded us yesterday, made a boastful appearance in *Born Rich*, the 2003 documentary about young, privileged New Yorkers (including Ivanka Trump and Georgina Bloomberg) that still haunts everyone connected with it.

"I've never actually dated outside my social background. I guess it's your compatibility, somebody on your same wavelength, understanding where you came from," Ercklentz said on camera. "I'm sure I would, but he'd have to understand that I love going shopping somewhere and spending all this money on something."

In 2019, Coleman was linked to the purchase, through a family trust, of a \$17.3 million home on Palm Beach's Everglades Island. Given Shleifer's \$132 million splurge this week, he's going to have to upgrade if they want to keep up with the Joneses.

## Meet Donald Trump's maxed-out donors, believers in the cause

WASHINGTON – Letantia Bussell, a Beverly Hills dermatologist, says she appreciates Donald Trump’s “unique personality.” Peter Zieve, an engineer in Washington, loves Trump because “the guy’s a person, not a robot.” Daniel Arias, an El Salvadoran immigrant in Florida, is positive Trump will put an end to newcomers “coming here and begging for food stamps.”

They are the few, the proud, the maxed-out Trump donors.

The leader of the Republican presidential contest ridicules donors and insists he is a billionaire who wants to “self-fund.” Yet there’s a prominent “donate” button on his campaign website, and he has raised more than \$9.5 million, including from about 200 people who have given \$2,700, the maximum allowed by law for the primary election.

Because it’s such a relatively small sample – a tiny sliver compared with Hillary Clinton’s nearly 29,000 maxed-out donors – it’s impossible to reach broad conclusions about Trump’s benefactors. Still, these are arguably the most loyal of Trump fans, and their interviews with The Associated Press reveal unexpected layers of the political newcomer’s appeal.

They’re both attracted and repelled by Trump’s inflammatory comments. Just like the thousands who attend Trump’s massive rallies, these well-off fans want dramatic change and see Trump as the only person capable of making it happen. And far from being embarrassed by their candidate, the donors seem to love converting their friends and associates to the cause.

The list of maxed-out donors includes some characters. Literally. One is Alice Chapman, a reality television star and the wife of Dog the Bounty Hunter.

Most people who part ways with several thousand dollars are on firm financial footing. Some of Trump’s donors are downright rich. John Ferolito, who co-founded AriZona iced tea, gave in July. And Scott Shleifer, head of the multi-billion-dollar New York hedge fund Tiger Global, ponied up \$2,700 last year, a few months before he purchased an \$18 million Park Avenue condo.

The AP culled the names of Trump’s top donors from his public Federal Election Commission filings, which are complete through the end of February. More contributors will emerge on Wednesday, when he files his March fundraising documents.

It’s all about immigration for Arias, himself an immigrant.

The 75-year-old real estate investor in Coconut Grove said he came to the country legally some 30 years ago.

“He’s the only one who is going to do something to stop illegal immigration,” said Arias, who contends many come here for the government benefits and “to steal and sell drugs.” Trump famously kicked off his campaign by saying some Mexican immigrants who entered the country illegally are “rapists.”

Some of the donors have taken issue with Trump’s most incendiary comments.

Zieve, an engineer who said he conducts business around the world and is a longtime Republican Party donor, said he’s “not proud of some the silly stuff he’s said.”

“Sometimes I wish he would put a zipper on it,” Zieve said.

At the same time, that no-holds-barred approach has kept him riveted – and supportive. Zieve gave \$2,700 at the end of February.

“Every time something comes out of his mouth, it’s exactly something that would come out of my mouth,” he said.

Bussell, the dermatologist, said she gave because she likes Trump, though she hasn’t met him. Trump, she said, has “a certain sense of humor” and doesn’t precisely mean everything he says.

“We don’t need more of the same,” she said. “We need a change. It’s as if the country is in need of a significant oil change and he is the best mechanic.”

The first person to donate \$2,700 to Trump’s presidential bid, weeks before he even glided down the escalator in his New York tower and declared his candidacy, was Pamela Newman, a friend and a longtime insurance provider for Trump’s business.

The campaign has been good to her, as well: Between June and February, it paid the branch of Aon Risk Services where she works almost \$300,000.

Yet not all of those who know Trump and gave him money are doing so for the usual reasons.

Joe Kaminkow, a well-known game developer, met Trump years ago when designing a slot-machine version of “The Apprentice,” Trump’s hit TV show. He described him as “a

gentleman.”

Still, he said, “I think we need a president who maintains our stability and strength with understanding. And he isn’t behaving in that way.”

So why the heck did Kaminkow, an admitted Democrat, give Trump \$2,700 in August?

“I was so entertained by what I saw from the Republicans on TV,” he said, “that I wanted to do my part to keep that party going.”

# NYC financier pays record \$122.7M for Donald Trump's former Palm Beach estate

New York financier Scott Shleifer, co-founder of Tiger Global Management's private equity unit,

has been revealed as **the mystery buyer** who splashed out \$122.7 million — cash — to buy **an oceanfront spec house in Palm Beach** that was once owned by Donald Trump. It's the most ever paid for a Palm Beach estate, or, for that matter, a home anywhere in the state of Florida.

"He flew in for the day, looked at the house for around 15 minutes, made the all-cash deal and then flew back to New York," a source who had knowledge of the deal told The Post exclusively.

"He's just a family guy who is really good at math," the source added.

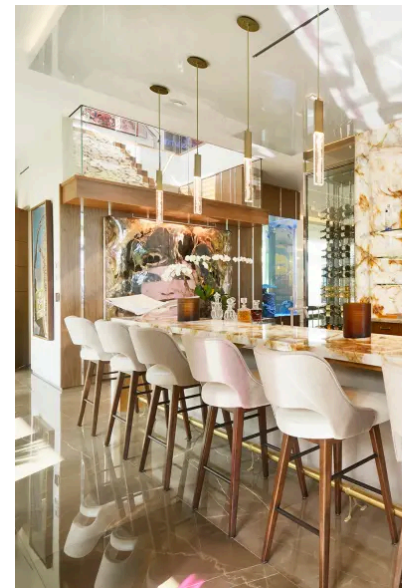
Shleifer's firm, which manages \$40 billion, had a stellar year in 2020 — and he's not alone.

New Jersey-based hedge funder David Tepper also just paid \$70 million for a Palm Beach pandemic mansion, **according to reports**.

"These guys are all the same," said the source. "For them, it's just a hedge against the market. They fly down to Miami or Palm Beach and go to a place like Cipriani's, which they know from New York. They get a table in the back, or just takeout because of COVID. These guys are super conscious of COVID. They don't want to be by people and they don't have to be in New York anymore. Nobody has to be here. You just know it. That's what's so insane. They can do whatever they want."

Shleifer's new digs come with a nine-bedroom mansion and a guest house, which together total 21,000 square feet. The main home is primed for entertaining, with large rooms, a bar, game room, wine cellar and beauty salon. The outdoor space features a pool and outdoor movie theater. Built last year, the 2-acre estate was on the market for a mere month, asking \$140 million.

But despite the astounding price point, the property, located at 535 North County Road, cannot shake its controversial history.

The land was once part of a 6.2-acre estate that housed Maison de L'Amitie, or House of Friendship. Ironically, the late pedophile Jeffrey Epstein and the former president, then a businessman, both fought for the estate when it was sold in a bankruptcy auction in 2005. Trump outbid Epstein, paying \$41.3 million for the property.

Before that, in the late 1980s, the property was owned by Epstein's benefactor, retail billionaire Les Wexner, who gifted Epstein his Manhattan mansion used by Epstein and Ghislaine Maxwell to groom and abuse underage girls and to host sleepovers for alleged fellow underage sex abusers, **like Prince Andrew**.

Wexner paid \$10 million for the Palm Beach estate in 1985.

In 2008, Trump offloaded the estate to Russian oligarch Dmitry Rybolovlev — who made headlines when he **bought Leonardo da Vinci's "Salvator Mundi" for \$450 million** — for \$95 million. The deal netted Trump a \$54 million profit and became a subject of Robert Mueller's Russia investigation.

Rybolovlev razed the house and sold three adjacent lots for the combined price of \$108.2 million, **according to reports** — less than the carrying cost of the property combined with the costs associated with tearing down the mansion.

Rybolovlev's spokesman once told this reporter that it was a smart deal because he would make money selling off the subdivisions — but Rybolovlev reportedly never made a penny on it.

In the most recent record-breaking deal, reality TV star and broker Ryan Serhant worked with Douglas Elliman's Christopher Leavitt to rep the buyer. Lawrence Moens of Lawrence A. Moens Associates repped the seller.
