Christmas of 2017 Mar a Lago:

Former President Trump was heard by two assets discussing detailed plans involving various back channel and illegal means of running his administration should he face any sort of complications while "Running The White House In The Same Manner As The Trump Organization".

During a dinner on the patio, Former President Trump told one of our assets along with Donald Trump Jr. and someone who was a trusted club member about clandestine discussions with Russian President Vladimir Putin without his administration's direct knowledge while bragging about the firing of former FBI Director James Comey.
